7.2 SAFETY CONCERNS STEPHEN STREET BINALONG

The Committee has previously considered a range of safety concerns raised by residents adjacent to Stephens Street Binalong particularly near the intersections with Fitzroy and Richmond Streets. See following map



As a result of previous discussions within the Committee TfNSW has undertaken a range of safety improvements including:

- 1. Extended the 50kph speed limit approx. 150 metres towards Yass
- 2. Improved line marking
- 3. Improved signs eg curve warning signs

In an effort to assist the residents and address their concerns a report was prepared for Council's August 2020 meeting which resolved the following:

- 1. Council work with TfNSW to install traffic barriers adjacent to the residents at the intersection of Burley Griffin Way (Stephens Street) with Fitzroy and Richmond Streets.
- 2. The installation of traffic barriers be funded from the State Road Reserve.
- 3. TfNSW be requested to install fixed speed cameras in Binalong.
- 4. Council's portable VMS board be made available.

Council has commenced concept designs with input for TfNSW.

7.3 TRAFFIC SAFETY CONCERNS GRAND JUNCTION ROAD YASS

SUMMARY

To consider a request signed by a number of resident in relation to traffic safety concern in Grand Junction Road.

RECOMMENDATION

That the Committee consider and provide comment on the concerns raised.

FINANCIAL IMPLICATIONS

All associated costs will be funded from existing Operational Budget.

REPORT

Council has received a request signed by 8 residents raising concern about traffic safety particularly with the completion of the Wellington Road Sub-division (47 lots) and a current application for 49 lots on the adjacent undeveloped land plus the potential for more development on surrounding land. See redacted letter. It is noted that the section of Grand Junction Road where the concern has been raised is a no-through road. See map below.

To whom it may concern,

We live out on Grand Junction/Guginya Place/Burrai Place in Yass and have been watching the changes to the access road to our houses due to the Wellington Road development. The widening of Grand Junction and termination of Therry St has resulted in an increase in concerns regarding safety amongst residents. Grand Junction has now been created as the through road and will be one long straight stretch of road that we feel will encourage speeding and dangerous driving.

The access road has always had a problem with speeding and the blind corner (outside Guginya Place entry). There is regularly people walking their dogs or going for a run throughout the day along the road as there is no footpath or shoulder, and they often have cars driving past with little regard for pedestrian safety. The majority of residents in the area have children which adds to the concerns re safety with walking into town and walking to catch the school bus (located up on Lead Street).

We would like to request the installation of a speed hump (or other traffic control measures) at the end of the new double lane and prior to the driveway into 11 Grand Junction to discourage 'hoons' and improve the safety through decreasing the speed on the road.

There is a perceived speeding problem in Murrumbateman being reported – at least 10 reports now, over 12 months. Its hard to know numbers and speeds of vehicles. In this instance it is Scrubby lane Jiparu Drv, and McIntosh Crt involved..

I have numerous speeding reports from West St, South St and Rose St in Murrumbateman. Some resident say they have made reports to police but others have said they do not want to.

Clearly this needs further investigation.
