#### **REPORT**

Youth Council members will be asked to nominate either themselves or someone else within the Youth Council for the roles of Youth Mayor and Deputy Youth Mayor.

The role of the Youth Council is to:

- Voice the opinions and concerns of young people in Yass Valley to the Yass Valley Council, State and Commonwealth Governments, and the wider community.
- Work with other youth agencies to develop and promote activities for, and social interaction between, the young people of Yass Valley.
- Raise awareness of health, well-being and safety issues that affects the young people of Yass Valley.
- Work with other youth agencies to encourage and co-ordinate participation and consultation between available regional youth services.
- Develop a sense of citizenship in the young people of Yass Valley by developing an appreciation of and interest in, local, State and Commonwealth Government processes through involvement in community projects.

The Youth Mayor chairs all Youth Council meetings at which she/he is present and is the official representative of the Youth Council (that is, attends functions and activities on behalf of the Youth Council). In the event of the Youth Mayor leaving the meeting or being absent the Deputy Youth Mayor acts as the Youth Mayor and performs the duties. In the event of both Youth Mayor and Deputy Youth Mayor not being in attendance at the meeting, then the meeting must be adjourned to another date.

All Youth Councillors (members of the Youth Council) represent the views of their peers, schools and the wider community at meetings and events.

Youth Councillors are expected to carry out functions delegated to them at the Youth Council meetings and working parties.

Council staff (Lynette Safranek and Hannah Sparks) and a Council representative (Cr Cayla Pothan) are always present for the meetings and activities, to guide and assist. Youth Councillors can call upon the staff at any time for assistance or advice.

#### 1.2 REGION-WIDE YOUTH MENTAL HEALTH AWARENESS MONTH

### **SUMMARY**

To present opportunities for the Youth Council to be involved in the Region-Wide Youth Mental Health Awareness Month (8 September to 8 October 2022).

- 2. The Youth Council nominates ideas for local event/s.
- 3. At least three Youth Councillors be nominated to help run local event(s).
- 4. Up to two Youth Councillors be nominated to help run a social media campaign.

Nil. The Department of Regional NSW will provide Council with a \$5,000 grant to cover the costs of participating in the Region-Wide Youth Mental Health Awareness Month.

### **REPORT**

## **Background**

At the March Youth Officers Network meeting, councils in the southeast region identified several collaborative projects to help bridge gaps in our communities relating to youth mental health.

One of the proposed projects was to host a region-wide mental health event, taking inspiration from the work Hilltops Council did in 2021 by running a '30 days of happiness' social media campaign and delivering 250 care packs containing mental health awareness materials to its youth.

Since then, the Office of Regional Youth has announced that it is keen to support this initiative by providing funding for a Region-Wide Youth Mental Health Awareness Month and partnering with the Youth Officers Network and Department of Regional NSW to deliver this to our communities.

The Department of Regional NSW is providing up to \$5,000 to each of the below councils (total \$45,000) to cover the costs of running a Region-Wide Youth Mental Health Awareness Month:

- 1. Yass Valley Council
- 2. Hilltops Council
- 3. Eurobodalla Shire Council
- 4. Wingecarribee Shire Council
- 5. Goulburn Mulwaree Council
- 6. Queanbeyan-Palerang Regional Council
- 7. Snowy Monaro Regional Council
- 8. Upper Lachlan Shire Council
- 9. Bega Valley Shire Council.

In June, the Youth Officers Network agreed that the Region-Wide Youth Mental Health Awareness Month will run from 8 September to 8 October. This will coincide with R U OK? Day on 8 September 2022 and Mental Health Awareness Month (October 2022).

#### Overview of the month

The funds will cover the following expenses:

- 1. '30 days of happiness' social media campaign,
- 2. Care packs containing mental health awareness materials, and
- 3. At least one local event.

### **Intended Outcomes**

- Region-wide recognition of the importance of mental health conversations and awareness throughout southeast communities.
- Increasing community capacity to respond to mental health concerns in youth.
- Empowering youth to engage in conversations concerning their mental health, helping others, and knowing where to access further services.
- Identifying and defining positive and poor mental health in youth, i.e., what constitutes mental health, such as anxiety, depression, emotions etc. that youth should be aware of.
- De-stigmatising mental health. Building greater knowledge in the community on what constitutes mental health and wellbeing and ways to improve mental health and wellbeing (i.e., motivational speakers, 30 days of happiness campaign, exercise, practicing mindfulness, etc.)
- Social media campaign with prizes youth activities, mindfulness, and ways to practice wellbeing every day.

As part of the funding objective, Yass Valley must engage with a minimum of 250 youth during the month. This can include through social media posts, care packs, and an event.

## Mental health awareness event

Ideas suggested or run previously by other councils include:

- BBQ
- Workshops i.e., Youth Mental Health First Aid
- Guest speakers
- Exercise bootcamps i.e., yoga
- Care pack deliveries

These could be run in multiple locations across Yass and its villages.

### '30 days of happiness' social media campaign

The idea is to create 30 posts that all participating Councils can use/share. We are looking for Youth Councillors to be involved in helping create and edit the posts to ensure they successfully engage youth.

#### 1.3 YOUTH OPPORTUNITIES GRANT

### **SUMMARY**

The NSW Department of Communities and Justice is offering grant funding for a project that focuses on giving young people the opportunity to develop a range of skills, including life skills and healthy behaviours; leadership, communication, and teamwork; event management and planning; and providing volunteering opportunities that link young people to further education and training.

### RECOMMENDATION

The Youth Council decide if they would like to create a project for staff to apply for funding.

#### **REPORT**

This grant application is open now and needs to be submitted by 8 August 2022. We can apply for between \$10,000 and \$50,000.

Eligible activities include those that will:

- Partner with young people to deliver a youth-led and youth-driven community project.
- Improve young people's access to and inclusion in community activities such as sport and recreation, cultural and other activities.
- Provide young people with knowledge and skills to strengthen their ability to participate in their local community and support future economic participation. Applicants can include group-mart configured references.
- Recognise the contribution young people make to their local community.


The main assessment criteria include whether the project:

- Demonstrates that young people have had and will have meaningful input at every stage of the project (identifying the need, planning and design, delivery and final review and recognition) the project is youth-led and youth-driven.
- Improves young people's access to and inclusion in community activities such as sport and recreation, cultural and other activities.
- Provides young people with knowledge and skills to strengthen their ability to participate in their local communities.
- Recognises the contributions young people make to their local communities.
- Supports young people's future economic participation.
- Clearly demonstrates substantial benefits to young people compared with the total cost of the project the project represents good value for money.

If the Youth Council have ideas of an event or activity they would like to put together, then staff can submit an application for funding and help the members put the activity together. This would be a great opportunity to provide youth within the Yass Valley local government area with a youth-led program.

## About the program

## **Program Overview**

The Youth Opportunities program provides one-off, time-limited grants of between \$10,000 and \$50,000 to non-government organisations and local government councils in NSW. Funding is for *new* projects that enable young people to lead and participate in community development activities.

Organisations applying for funding must have spoken with young people and involved them in developing the project proposal prior to submitting an application.

## NSW Government Priorities for Young People

The Youth Opportunities program aligns with the NSW Strategic Plan for Children and Young People 2022-2024<sup>1</sup>, which advocates that children and young people in NSW have hope for the future, love, connection and safety, a good standard of living, environments for joy and fun, as well as respect and acceptance.

The Youth Opportunities program contributes to this by investing in projects that strengthen young people's connection to their community via the delivery of youth-led and youth-driven community initiatives.

The NSW Department of Communities and Justice Strategic Direction 2020-2024<sup>2</sup> sets out the Department's vision for active and inclusive communities. The Department provides a range of community support to improve wellbeing, increase community participation, and promote social inclusion and cohesion.

The Youth Opportunities program is administered by the Department of Communities and Justice.

## Program Aim

The Youth Opportunities program is informed by evidence which indicates that community connectedness<sup>3</sup> promotes a positive sense of wellbeing in young people. Young people can however experience a range of barriers<sup>4</sup> that hinder their participation in the community.

The Youth Opportunities program aims to increase young people's participation in activities that strengthen their connection and belonging to their communities.

The Youth Opportunities Program supports organisations to empower young people to design and deliver community projects, enabling them to:

- · overcome barriers to participating in the community
- build community based partnerships and networks
- · feel a greater sense of belonging within their community
- feel empowered, as their ideas and opinions are respected, considered and acted upon
- gain relevant training to support their participation
- feel more confident within themselves and their abilities, having expanded their knowledge and skills
- seek further opportunities to participate and stay engaged in their community.

## **Project Objectives and Core Components**

Projects funded under the Youth Opportunities program are to involve young people at every stage of the project. It is expected that young people will take an active role in identifying, designing and implementing these projects.

Projects are required to meet the following objectives and core components:

## Intended Outcomes

The Youth Opportunities program aims to contribute towards the following outcomes:

Project Outcomes (short-term)

- Increased participation in youth-led and youth-driven community activities
- · Young people address and overcome barriers to participation
- Young people participate in activities that strengthen their connection to their local community
- Young people learn a range of skills that strengthen their ability to participate in their local community and support future economic participation
- Young people's contributions are recognised and valued

Program Outcomes (medium-term)

- Young people feel a sense of choice and control (self-determination) in their lives
- Young people feel a sense of connection and belonging to their local communities

## Performance and Outcome Measures

Contributions towards these outcomes are tracked over the life of the project. Funded organisations are required to provide information against a set of measures and indicators at three intervals:

- commencement (participant survey)
- mid-term (progress report)
- completion (final report and participant survey)

## Community Based Partnerships

The Youth Opportunities program provides a unique platform for eligible organisations to build authentic and meaningful partnerships with young people in their community. The more successful these relationships are, the more likely young people are to seek further opportunities to participate and stay engaged in the community beyond the project.

Funded organisations are to engage young people in a way that evokes a shared sense of responsibility and ownership across all stages of the project including planning, design, delivery and evaluation.

Successful partnerships<sup>5</sup> strike the right balance between enabling youth ownership whilst providing the right organisational supports and resources required to participate. To do this effectively, adults must be willing to share their power with young people and work in partnership on issues that are important to them.

Working in partnership with young people requires organisations (adults) to have the flexibility to step in and out of the process as required, without taking over. It is also important that young people are able to dictate the nature and level of their involvement.

In 2016, the Advocate for Children and Young People consulted with 150 young people to develop a 'Participation Charter' which states *We respectfully request that adults assist us to make meaningful contributions by*:

- providing guidance, balanced with independence
- · providing training and skill development
- providing resources and financial support
- · understanding that we have many commitments
- encouraging us to work collaboratively
- fully informing us of our role and our rights in the decision making process.

## Youth-led and Youth-driven Community Projects

The Youth Opportunities program funds projects which are genuinely youth-led and youth-driven. This means that young people are involved at every stage of the project - from identifying the need, through to design, delivery and final review (see page 9, Life Cycle of a Youth Opportunities Project).

Applicant organisations must have the capacity to encourage, support and facilitate a youth-led and youth-driven community project.

## **Target Group**

Young people 12 - 24 years of age who are transitioning from childhood to adulthood and from dependence to independence, including young people who face disadvantage.

The program seeks to fund a diverse range of projects from across NSW, particularly in rural and regional areas, and encourages applications from Aboriginal and Culturally and Linguistically Diverse organisations.

# **Project Themes**

## Priorities Identified by Young People

Young people have told us through a number of different mechanisms what is important to them, what concerns them, and what they are interested in<sup>7</sup>.

The following themes highlight key issues identified by young people:

- · Community inclusion and participation
- COVID-19 recovery
- · Cultural identity and connection
- · Cyber safety and awareness
- · Domestic and family violence
- Healthy relationships
- Financial literacy (budgeting, rent, phone, contracts, fines)
- · Health and wellbeing
- · Homelessness/housing
- Natural disasters (preparedness, resilience and recovery)

Youth Opportunities projects may seek to address one or more of these issues, or they may address other issues raised by young people, which are important to them and their local communities.

Applicant organisations are to engage young people in the initial 'Identifying the need' stage of the project (see page 9, *Life Cycle of a Youth Opportunities Project*) to ensure the project is responsive to the needs of young people.

While addressing a youth identified issue, all applications for funding will be asked to demonstrate how they are supporting young people to build their skills and experience throughout the project, which can include hands on learning to build skills, or the completion of short courses related to the project's implementation.

Skills developed during funded projects help young people to participate in the social and economic life of their communities. Their participation and engagement through the funded projects helps to reduce social isolation, improve wellbeing, and generate positive change in their communities.

Applicant organisations must ensure the input of young people is firmly embedded in each stage of the project.

# Application for Funding

Non-government organisations and local Councils in NSW are invited to apply for a grant between \$10,000 and \$50,000 to deliver a Youth Opportunities project for up to 12 months.

All applicants must complete and submit an online application form which is available at <a href="www.youth.nsw.gov.au">www.youth.nsw.gov.au</a>. The NSW Youth website also includes downloadable resources to support the application process.

Deadline for applications is 5:00pm on Monday, 08 August 2022.

Applications submitted after the advertised closing date will not be accepted.

## Who Can Apply

Eligible organisations must be:

- an incorporated non-government (not-for-profit) organisation operating in NSW
- · a NSW local government authority

## Who Cannot Apply

You should **not** apply for this grant if you are:

- a Commonwealth or State Government agency
- a school (including P&Cs), a university or TAFE college
- · an individual or sole trader
- a commercial for-profit organisation
- a sub-contractor engaged to manage or deliver the project on behalf of a non-eligible organisation

## How to Apply

Applications are submitted via SmartyGrants, an online grants administration system. To access SmartyGrants and the online application form please visit <a href="https://www.youth.nsw.gov.au/youth-opportunities">www.youth.nsw.gov.au/youth-opportunities</a>

Applications must be completed and submitted online via SmartyGrants by **5:00pm on Monday, 08 August 2022.** The SmartyGrants system will automatically shut off at 5:00pm on that day. It does not allow for extensions to be granted.

## **Project Exclusions**

Projects will **not** be eligible for funding if they:

- are run in schools as part of the curriculum or other areas of school responsibility
- include interstate or overseas travel, scholarships and/or conference attendance
- · provide case-management or counselling for young people.

## Project funding must *not* be used for:

- religious festivals, rituals, events or promotions, except multi-faith events which involve young people from more than one religion
- major capital works (e.g. establishing or refurbishing a youth centre)
- large equipment purchases (e.g. vehicles)
- costs that are not directly associated with the implementation or delivery of the project
- operating expenses such as rent, insurance, electricity, water, rates or funding towards the running of other programs within the organisation
- · existing projects/programs
- projects/programs that have already been implemented at the time of application, after application or prior to contracting. Funding cannot be used to reimburse retrospective project delivery.

## **Project Budget**

A detailed budget identifying expenses as well as any in-kind contributions are required as part of the grant application.

### Project funding can include:

- costs associated with implementing the project, including project coordination
- up to 10% of the budget can be used for minor administration costs
- up to 10% of the budget can be used to purchase minor equipment (applicants must demonstrate the need for these purchases in their application)
- up to 5% of the budget can be used for catering.

## Assessment Criteria

Each application will be considered on its merits, based on how well it meets the assessment criteria and how it is ranked against other applications. Assessments are conducted by Independent Assessment Panels.

Each application is assessed against the following criteria:

- The project demonstrates that young people have had and will have meaningful input at every stage of the project (identifying the need, planning and design, delivery, final review and recognition) the project is youth-led and youth-driven
- The project improves young people's access to and inclusion in community activities such as sport and recreation, cultural and other activities
- The project provides young people with knowledge and skills to strengthen their ability to participate in their local communities
- The project recognises the contributions young people make to their local communities
- The project supports young people's future economic participation
- The project clearly demonstrates substantial benefits to young people compared with the total cost of the project - the project represents good value for money

Recommendations for funding are made to the NSW Minister responsible for Youth. Please allow up to 16 weeks for advice regarding the outcome of your application. All applicants are notified in writing.

## Successful Applicants

Successful applicants will enter into a Funding Agreement with the Department of Communities and Justice and will be required to report on the progress and completion of the project. See **Appendix B** Reporting and Data Collection on pages 16-17. Specific reporting requirements will be advised once the grant is approved.

Once the project is completed, any unspent grant funds, or grant funds not expended in accordance with the Funding Agreement must be returned to the Department of Communities and Justice.
