Possible focus for present and future social sustainability issues facing Yass LGA

September 2022

Considerable data regarding population health profiles has been collected from numerous agencies, including the ABS, then collated and continually updated, by the research group 'Coordinaire' in their report "Population Health Data" covering all the 12 LGA's in the SE NSW PHN (Primary Health Network).

The data has been presented in 72 tables, under the broad headings of Geography, Demography, Social Determinants of Health, Epidemiology, Primary Care and related Insights. The Yass LGA emerges with significantly less socio-economic disadvantage

However, current areas of significant need in Yass LGA that emerge from this wealth of data, and are consistent with findings in the UC Wellbeing Survey and Draft YVC Housing Issues Paper 2021 include

• First Nations People – Closing the Gap -their Health and Wellbeing remains below state averages on every parameter including Housing availability and affordability

Housing Issues –

large older houses with a single older occupant lack of affordable housing and rental lack of ageing-in- place housing lack of crisis accommodation lack of short-term rentals

Health and Wellbeing

Insufficient support for lonely elderly; mental health all ages; young parents

Transport-

Lack of adequate, affordable public transport available throughout Yass LGA Lack of safe Bicycle paths and Bicycle storage areas; poor pedestrian walkways No widespread and organised car-pooling – how to improve this? Prohibitive costs of electric cars at present – how to increase use / ownership?

Volunteer / NGO organisations

Need renewal with younger cohort, more community involvement Designated housing for such organisations in the YLGA area

- Sustainability Education Queanbeyan Palerang LGA have a designed a well-advertised Sustainability Policy that regularly advices their community of available rebates and incentives, together with a quarterly newsletter 'All Things Sustainability". They have produced a Community Climate Action Plan 2020-2030, with 79 actions recommended to mitigate and adapt to climate change, under the following headings Energy, Transport; Waste; Water; Adaptation; Education; Natural and Urban Environment.

Hi Cr Cameron,

Answers below in blue.

1 Has Council given thought to implementing a FOGO program for the Yass Valley?

2 What are the barriers to implementation for a FOGO program (including costs if known)? A collection round is about \$80-90 per household per year for a fortnightly collection without costs for disposal which are unknown. As you have been previously briefed, we are working with the CRJO for a regional waste strategy as we are too small for a facility on our own. Recent changes by the EPA are likely to impact FOGO processing. It is unknow what impact this will have on the ability of Councils to process FOGO.

3 Have any surveys been undertaken to gauge desire for a FOGO program in the region? Not that we are aware of.

4 Do you have a list of FOGO processing facilities nearby? Is there scope for Yass to use these if a FOGO program was implemented?

5 What are other nearby Councils doing in the FOGO space? Could we draw on their expertise and resources? We are working with the CRJO on a regional waste strategy which will include FOGO or GO.

6 Does the Council have data on the Yass Valley's greenhouse gas emissions and what the major contributors are to these emissions (e.g. agriculture, transport, natural gas, etc)?

No. I was unable to find this on the EPA Website, but they may have data.

7 Has the Council/Yass Valley signed up to any emission reductions targets/schemes? And how are we reporting against these targets?

8 What is the Council doing in the circular economy space? Are there any plans in place to support YVC move to a circular economy?

Following legislative recycling and waste management requirements.

9 What recycling facilities/technology do we have in the Yass Valley and are there any gaps which mean things that could be recycled are sent to landfill instead?

The only facility we have in Yass is Martins Fertiliser who take some green waste. The rest is sent to centres in other locations. The major issue is the lack of separation of waste at source by commercial waste companies and residents as we do not have the ability to sort waste at the Transfer station if it is incorrectly placed in bins or the waste pit.

10 Why was the Yass Revolve closed? Are there any plans to reopen a facility where households could drop their high-quality bulky waste for reuse?

The commercial realities are that Yass does not collect sufficient quantity of quality product to make the Revolve Shed viable. It would cost approx. \$100k per year to run the facility with only very limited recovery.

11 What proportion of Yass' waste is sent to landfill? Is there a plan to reduce waste to landfill in the Yass Valley? Are you able to share details?

Approx. 45% of waste is sent to landfill. Currently work with CRJO on regional waste strategy which will include education of residents. Working with commercial contractors for source separation.
