5.1 FOOD ORGANICS AND GARDEN ORGANICS SERVICE

SUMMARY

4.3 ELECTRIC VEHICLE UPDATE

SUMMARY

To present an update on the take up of electric vehicles.

RECOMMENDATION

REPORT

In July 2022 the Committee considered a report on electric vehicles and determined that:

- The Council decision to closely monitor the domestic electric vehicle market, the range of vehicles
 offered, incentives, prices and infrastructure upgrades, to ensure that future decisions made consider
 fit-for-purpose and providing value-for-money be supported.
- 2. Representations made to the Federal Government for the Fringe Benefit Tax on Electric Vehicles be removed as an incentive for Local Councils to move their light vehicle fleet away from petrol and diesel vehicles be supported.

Fringe Benefit Tax

The Fringe Benefit Tax on Electric Vehicles has been removed.

As indicated in the July 2022 report Council staff will continue to monitor purchase costs of EV and potentially, when deemed feasible Council's fleet staff will consider adding EVs to Council fleet especially for staff travelling large distances on an annual basis. There are several hybrid cars in the current fleet. The move to electric vehicles will be considered as fleet vehicles come up for replacement. Council cars are changed over every 3 years or 120,000km whichever comes first.

Charging Station

The Tesla charging station in the 'Kiss and Ride' car park at the rear of the Club Hotel are currently being installed. The charging stations are in place (the bases needed to be redesigned due to the 1 in 100 year flood zone) and some street work is being undertaken in the week commencing 16 October 2023. Following connection by Essential Energy they should be operational in mid-November 2023.

Electric Mowers

In March 2023 Council parks staff were involved in a demonstration of electric mowers in Riverbank Park.

Staff were impressed by the mower and how it performed, however, questions were raised regarding longevity of the mowers outside of maintained parks (e.g. roadside maintenance). The supplier did provide assurance that the mower would continue to perform, however did not have enough "in the field" data to support their contention.

At this stage the cost of electric mowers are double that of conventional mowers. The main difference is the cost of maintenance and fuel with electric mowers essentially recovering the cost of maintenance and fuel well before the completion of their 5-year warranty period.

At the time of demonstration most Council or Government sales such as the ACT Government have not had the equipment in service long enough to provide quality performance data. Parks staff are continuing to monitor the uptake of electric mowers and performance data.

4.5 COMMUNITY ENGAEMENT IN THE DESIGN OF FOGO SERVICE - CURRENT STATUS AND ISSUES

SUMMARY

At its 19 September 2023 meeting the Committee recommended that Council conduct of a bin audit, consistent with the guidelines issues by the EPA, in order that necessary data be collected to assist in the design of a future FOGO collection service. In parallel with the bin audit, it was decided that the Committee would start engaging with the community on a future FOGO collection service, adapting materials from other local councils as appropriate. Also, as part of this engagement, the Committee would as a first step establish focus groups seeking participants from existing community, environment and business organisations in Yass Valley.

Since that meeting several steps have been taken to progress these matters and further work identified that needs to be followed through.

RECOMMENDATION

That the actions taken to date in progressing with its engagement work and the additional work now required be noted.

FINANCIAL IMPLICATIONS

The introduction of a FOGO service will have financial implications for Council which needs to be identified as part of the design of a scheme.

REPORT

1. Introduction

An engagement / research strategy (refer <u>Attachment A</u>) has been drafted to both set out the broad approach to engaging the community and, specifically, to outline a preferred methodology for the conduct of focus group sessions.

A basic background document, or participant information sheet, has been developed to inform focus group participants in advance of group sessions (refer <u>Attachment B</u>).

A contact list of community groups has been provided by Council staff (refer <u>Attachment C</u>).

A number of focus group sessions have been scheduled with village progress associations (Binalong and Murrumbateman) and the methodology established in the engagement / research strategy tested with members of the Bowning District Progress Association at a meeting on 18 October 2023.

2. ISSUES

2.1 Bin Audit

It is clear based upon the trial session conducted with the Bowning & District Progress Association that the bin audit will need to be of sufficient size to establish the character and volume of waste generated in the villages as well as town centres. The strong perception is that both food and garden organics are being diverted already from the residual waste stream, although experience from other NSW jurisdictions suggests that this may not actually be the case.

2.2 Contact List

Council has provided the attached list based upon its records but it is not definitive. There may be other community groups that can be approached to participate. Yass FM has its own record of community groups and associations and there may be others known to Committee members.

2.3 Data

When reviewing the paper provided by Council to the September 2023 Committee meeting, the Business Paper report of 25 March 2020 and Council's reporting to the EPA it is clear that there is inconsistent and contradictory data being used / reported by Council.

A definitive set of accurate and up-to-date data will be required in combination with bin audit results if the Committee is to provide useful advice to Council. Accurate and up-to-date data is also valuable in the conduct of the focus group sessions, as well as necessary in the making any future grant applications.

At a minimum the required dataset should cover:

- Volume and weight of actual green waste collected at transfer stations (averaged over number of years and major variations explained)
- Number of current weekly residual waste (red bin) collections and estimated growth
- Current and estimated capacity of the existing collection vehicles (including major variations in daily and seasonal patterns)
- Current and anticipated landfill costs per tonne
- FOGO processing gate fees per tonne at regional facilities
- Estimated transport costs to regional facilities
- Existing and future anticipated capacity of regional processing facilities
- Equipment and labour costs (eg. it is unclear why the March 2020 report references both outright purchase and leasing costs for vehicles)
- Available surplus funding from the Waste Services Business, given existing and anticipated commitments
