3.1 MURRUMBATEMAN PUMP TRACK LOCATION

SUMMARY

To consider a location within the Murrumbateman Recreation Grounds for the construction of a BMX/Pump track.

RECOMMENDATION

That the Murrumbateman BMX/Pump Track Focus Group committee members endorse the location for the construction of a BMX/Pump track over the southern sand arena within Murrumbateman Recreation Grounds.

FINANCIAL IMPLICATIONS

Actions identified in the report will require the approval by Council before any commitment or adjustment to the Operational Plan is made.

POLICY & LEGISLATION

- Local Government Act 1993
- Parks and Playground Strategy 2017
- Everyone Can Play Guidelines.

REPORT

1. BACKGROUND

The determination from Council at its meeting on 22 May 2025 resolved (Min No 184) that Council endorses 10 Hercules Street, Murrumbateman as the location to construct the all-abilities playground. This means that the southern sand arena within Murrumbateman Recreation Ground is available.

As discussed at the previous meeting Council has investigated possible options to fit a pump track of approximately 1 500m² in size. These locations being:

- Murrumbateman Common
- Murrumbateman Recreation Ground southern sand arena
- Hawthorn original proposed playground location

Although the sites of Hawthorn and the Murrumbateman Common are of adequate size to accommodate a "competitive level" pump track these locations pose the following issues/risks:

- Outside of main village area
- No infrastructure in vicinity such as water and sewer services
- > No amenities such as public toilets, off-street parking
- ➤ Biodiversity assessment would need to be undertaken high risk of biodiversity concerns
- Limited natural surveillance

2. MAP LOCATIONS FOR PUMP TRACK

MURRUMBATEMAN COMMON

The "Common" is approximately 39 600m² in size and is accessed off either Nirta Drive or Morrison Place:



HAWTHORN

The area proposed is approximately 12 000m² and is accessible off Merryville Drive:



MURRUMBATEMAN RECREATION GROUND (Southern Sand Arena):

The southern sand arena is approximately 2 800m² and is accessed from the Barton Highway or Murrumbateman Road:



3. MURRUMBATEMAN RECREATION GROUND FOCUS GROUP

Council has approached members of the Murrumbateman Recreation Ground Focus Group out of session to endorse the repurposed intended use of the southern sand arena from the playground location to a pump track site.

Responses from the focus group will be presented at this meeting.

4. RECOMMENDATION

That the committee consider the southern sand arena within the Murrumbateman Recreation Ground as the preferred location to construct a pump track.
